I further hereby consent to release from any future liability or negligence the NWACC IDL and NWACC and its trustees, employees, faculty, staff, agents, instructors, and all individuals assisting with NWACC IDL programs for injury, personal property damage, or death caused by or resulting from my participation or in any way connected with my participation in NWACC IDL programs, whether such injury, personal property damage, or death was caused by NWACC IDL, its representatives, another participant, or any other person or cause.
- E. I agree to defend and indemnify the NWACC IDL and NorthWest Arkansas Community College for loss or damage, including any that result from claims or lawsuits for personal injury, death, or personal property damage, relating to NWACC IDL or use of NWACC IDL facilities or equipment.
- F. I authorize any person connected with NWACC IDL to administer first aid as deemed necessary. I authorize medical and surgical care and transportation to a medical facility or hospital for treatment necessary for my well-being, at my expense.
- G. I acknowledge that certain individuals holding enhanced carry permits are allowed to carry concealed handguns on NWACC's training site pursuant to Ark. Code Ann. § 5-73-322 and that the presence of any such weapons on NWACC's property is outside of NWACC's control.

This agreement is governed by the laws of the State of Arkansas, and exclusive jurisdiction shall be in the circuit court of Benton County, Arkansas and/or the United States District Court, Fayetteville, Arkansas division. If any part of the agreement is determined to be unenforceable, all other parts shall be given full force and effect.
- I. This NorthWest Arkansas Community College Integrated Design Lab Liability Waiver will apply for each and every day I participate in NWACC IDL programs.
